This representation letter is also provided in connection with your audit of the federal and state award programs of the District as of and for the year ended June 30, 2024, which was performed in accordance with auditing standards generally accepted in the United States and Title 2 U.S. Code of Federal Regulations (CFR) Part 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards (Uniform Guidance); and the standards for financial audits contained in Government Auditing Standards, issued by the Comptroller General of the United States; and the State of Wisconsin Single Audit Guidelines.
